In addition to the transactions detailed above, a bridging loan of £405,000 had been advanced to the East Mercia Circuit during 2023-24 and this was repaid on October 24th 2024.

9. District Officer's comments and report.

The balance held in the DAF has increased significantly for the following reasons.

- The sums held in Circuit Model Trust Funds have grown resulting in an increase of more than 50% in the levies paid to the DAF, when compared with 2023-24.
- The CPF distribution increased by more than 20% compared with the previous year.
- £245k has been received for Action for Hope grants.
- The London Committee has changed the method of distributing grants from the London Mission Fund so that the Districts now receive the full allocation and are responsible for paying the grants to circuits and churches.

The value of the grants that have been paid has increased slightly, but it appears that there is a continuing reluctance to commit to new projects and there have been difficulties in recruiting and retaining staff.

It is our policy to keep the uncommitted balance as low as possible and the value of our future commitments has increased by more than £200k but, due to the additional funds received, the small over commitment on 31st August 2024 has become an under commitment of £578k.

Circuits with large Circuit Model Trust Fund balances (over £100,000) are encouraged to use their funds imaginatively and grant applications are normally only considered if a Circuit contribution is being made. The Mission Team Leader is in contact with Churches and Circuits to advise and support them and he ensures that new proposals follow the Mission Policies of the District and Circuits and the priorities of the Methodist Church.

10. Monitoring and Evaluation

In addition to continuous and routine informal monitoring, if a personnel project has been awarded a grant for more than one year, the second and subsequent payments will not be made unless an Impact Monitoring and Evaluation report of the activities undertaken has been received and approved by the F & G Committee. Several payments have been temporarily withheld due to the failure of the recipients to submit reports.

A Property Panel advises Churches at an early stage, particularly for larger property schemes and property schemes that were approved over 3 years ago are reviewed to ensure their continuing viability.

All recipients of a grant from the DAF are expected to provide a report at the end of the project.
